IN CONSIDERATION of being permitted to participate in this rifle tournament on the premises of or under the auspices of Hawks Ridge Gun Club, on my behalf or on behalf of the participant named above if participant is a minor (we will collectively call ourselves "I" in this release) I acknowledge, appreciate and agree that:

1. The risk of injury from the activities involved in this tournament is significant, including the potential for permanent paralysis or death. This risk includes, but is not limited to, my being in the presence of and/or using firearms and includes but is not limited to property damage, injury, or death resulting from the dangers or conditions that are an inherent risk of firearms activity.
2. By signing this RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, I UNDERSTAND AND KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, EVEN IF ARISING FROM THE CARELESSNESS, RECKLESS, NEGLIGENCE OR LEGAL LIABILITY of those persons released from liability below, and assume full responsibility for my participation. I understand that there may be other risks, as well, and I agree to assume them; I am not relying on the above named club to list all possible risks for me.
